4. ORGANIZATION RECOGNITION REVIEW:

a) Pico Rivera Baseball Academy - Anthony Corona

President of Pico Rivera Baseball Academy, Anthony Corona, informed the Commission that this was his 9th year with the organization. He provided flyers of the Organization's Annual Barbecue that included a short history and photographs of the teams. He also provided a brief background of his involvement with the Organization and the Organization's goals.

Commissioner Palombi welcomed President Corona and stated that he has attended several Pico Rivera Baseball Academy Banquets. He noted that he has always been impressed with the gratitude President Corona has expressed to the participants.

Commissioner Lay stated that additional screening would be installed at Rivera Park. He also inquired about purchasing door stoppers for the outdoor restrooms by the concession stands at Rivera Park. He further stated that a senior citizen had walked into the women's restroom and slipped. He also noted that Rivera Baseball Association had their Opening Day Ceremony and had a great turnout. The Channel 4 News Anchor, Alicia Del Valle, also attended the Opening Day Ceremony.

Commissioner Palombi had nothing to report on the park sites. He only requested an update on his request to add additional Youth Centers around the City for the youth.

Commissioner Rodriguez stated that he was able to attend the Pico Boys Opening Day Ceremony. He further stated that it had been an honor to attend and witness the enthusiasm from all the families in attendance. He noted that the locks at the Youth Center had been installed. He also agreed with Commissioner Palombi and stated that the City needs more youth facilities.

Vice-Chair Sanchez stated that she attended the Pony Boys Opening Day Ceremony. She also mentioned that State Senator, Bob Archuleta, was able to purchase new flag poles for the Smith Park stadium. Several residents had shared with Vice-Chair Sanchez that there had been a lot of trash on Monday and Tuesday mornings that were probably left over from the weekend before. She also attended the Trips & Tours Excursion to the Pantages Theater to watch Cats, a musical performance. She also attended an event at the Pico Rivera Sports Arena and lightweight fighter Angel Rodriguez was in attendance.

Senior Manager Meacham noted that there was only one staff scheduled for park maintenance over the weekend.

Chair Saucedo asked if there was anything the City would be able to do to recognize all the coaches and volunteers.

Vice-Chair Sanchez requested an update on the Pico Rivera Golf Course.

Senior Manager Meacham noted that they were scheduling a meeting with the Health Department and they were working diligently to open the Golf Course Bar and Restaurant.
