Important voter and community information for the November 2022 ballot measure.













### What is **Measure AB?**



Measure AB is a ballot measure that will be on the November 8, 2022 ballot.



Measure AB is <u>not a tax increase</u> on residents in Pico Rivera.



Measure AB will update the city's business fee, which has been largely unchanged since the 1960s.



Measure AB will provide \$5.8 million annually that goes directly back into Pico Rivera.



Measure AB will provide a more equitable structure between big and small businesses.

### Measure AB is not a Tax on residents.

Measure AB does not increase the sales tax in Pico Rivera.

Measure AB does not increase property taxes in Pico Rivera.

Measure AB is not a parcel tax on property owners.

# **How may Pico Rivera benefit from Measure AB?**

# \$5.8 million

in new annual revenue that goes back into the community to fund essential services.

#### **Measure AB revenues can be used for:**

- Crime prevention + improve 911 response times
- Keeping public areas clean and safe
- Protect local drinking water sources
- Repair streets and potholes
- Maintain essential city services
- Prevent youth and gang violence

# Why does the City need Measure AB?



#### **PUBLIC SAFETY**

City leaders have sought to secure and protect Pico Rivera by enhancing public safety to confront personal and property crimes while improving 911 response times.



#### **IMPROVE STREETS**

The City has focused on ways of addressing the City's Long-Term Strategic Plan, which includes street improvements, fixing potholes, protecting water quality and addressing aging city buildings and facilities.



#### **CLEAN AND SAFE CITY**

Clean drinking water, clean and safe parks are critical to ensuring our youth, older residents and families can fully enjoy Pico Rivera.

Measure AB will help ensure our Parks and facilities are maintained clean and safe.

## How are some businesses impacting city services?





Pico Rivera's business license structure has hardly changed since the 1960s and the structure puts unrelated businesses together.



Some businesses have a heavy impact on the quality and longevity of the City's roadways and public infrastructure.




The City's business fee does not measure impacts on City Services based on the type of business.





The current business license structure is **not equitable** based on **impacts** to the community **or cost to small business**.

### What is the current impact on Small Business?



### Measure AB will fix our 50-year-old business fee:







Re-categorize businesses into the <u>five types</u> that are most reflective of the City:

- General Commerce/Retail
- Rental (Commercial & Residential)
- Service
- Professional
- Contractors

Switch from a flat to tax to a gross receipts tax, which is better for small business and is generally more equitable regardless of business type.

By using a square-foot basis for industrial or warehousing uses, the City will recoup costs of addressing the maintenance of streets making sure they are maintained in good condition.

## **Summary:**

- Measure AB is **not** a tax on residents.
- Measure AB will update the City's business license structure, which has been largely unchanged since the 1960s.
- The City will generate approximately \$5.8 million dollars in new annual revenue that goes back into the community and cannot be used outside of Pico Rivera.
- The current business license structure is not equitable based on impacts to the community or cost to small business.
- Measure AB will help fix our outdated business fee structure while helping to invest in Pico Rivera's future.
