Description: The City of Pico Rivera (City) hereby notifies the general public of a public hearing on April 25, 2023, to receive public comment for the Fiscal Year (FY) 2023-2024 Annual Action Plan and Substantial Amendment No. 1 to the 2020-2025 Consolidated Plan. The City is an entitlement community and is expected to receive federal Community Development Block Grant (CDBG) funds from the United States Department of Housing and Urban Development (HUD) in FY 2023-2024 (July 1, 2023 – June 30, 2024).

As an entitlement jurisdiction, the City is required to prepare and submit to HUD an Annual Action Plan that generally describes how the City will utilize federal money during the next fiscal year to meet the goals and objectives approved by the City Council in the Five-Year Consolidated Plan. The Five-Year Consolidated Plan is a five-year plan detailing the priorities and needs of the community for the use of CDBG and HOME funds. The Consolidated Plan amendment will realign its goals with current City priorities by including a goal to address Neighborhood Preservation.

Proposed Amendment to the 2020-2025 Consolidated Plan will add a goal as noted below:

Economic Development – Business Assistance

FY 2023-2024 CDBG Annual Action Plan

For FY 2023-2024, the City expects to receive approximately \$559,364 in CDBG funds. Additionally, the City has approximately \$102,013 in unspent funds available for programming. The total available funds for programming as part of the FY 23-24 Annual Action Plan is \$661,377.

Priority Funding for CDBG activities are given to activities that:

- · Provide decent affordable housing
- Maintain and promote neighborhood preservation
- · Affirmatively further fair housing choice for all
- Provide public services for extremely low, low- and moderate-income residents
- Construct or upgrade public facilities and infrastructure
- Planning and administration
