

Mobilehome Park Rental Review Board Application

The City of Pico Rivera is currently recruiting applicants to serve on the inaugural Mobilehome Park Rental Review Board. If interested, read about the Board below and complete the attached application.

About the Board

The Mobilehome Park Rental Review Board is a five-member public body responsible for reviewing and ruling on applications submitted by park owners for:

- Capital Improvement pass-throughs (where owners seek to recoup costs of eligible improvements), and
- Fair Return rent increases (where owners request rent increases above the standard limits to ensure a constitutionally fair return).

This Board plays a vital role in preserving the long-term affordability of mobilehome park living while recognizing the rights of park owners to maintain and improve their properties.

What to Expect as a Board Member

Board Members will be appointed by the City Council and serve a two-year term. To maintain balance, the Board includes:

- One Mobilehome Owner,
- One Park Owner, and
- Three At-Large Members (Pico Rivera residents who are neither park owners nor residents).

Members will be asked to attend up to two meetings per month, though most months will only require one meeting or none at all. All meetings will be held in the evening at City Hall, and members will receive a stipend of \$75 per meeting attended.

This is a meaningful opportunity to serve your community and contribute to fair and transparent governance of mobilehome housing in Pico Rivera.
